Kuveyt Türk has launched the "Digital Vehicle Financing" service, a first of its kind in Turkey, allowing individuals who want to own a new or second-hand vehicle to complete all steps through the Kuveyt Türk Mobile platform.

## *Gold Banking*

### Gold Banking

Having started gold banking in 2007 and gold collection campaigns in 2011, Kuveyt Türk has contributed 44.9 tons of gold to the economy as of the of 2024. With a 9.1% market share in precious metals accounts in the banking sector and a 53.6% market share among participation banks, the Bank maintains its leadership in this field.

As the bank with the highest trading volume in the Precious Metals and Gemstones Market of Borsa İstanbul (BIST) since 2011, Kuveyt Türk has been a pioneer in physical gold buying and selling among banks. Moreover, Kuveyt Türk has successfully maintained its position as the first and only Turkish bank that is a member of both the London Bullion Market Association (LBMA) and the Shanghai Gold Exchange International (SGEI) as of 2024.

# KUVEYT TÜRK'S STRATEGIC EDGES

## Sukuk

### SUKUK

Since entering the sukuk (lease certificate) market for the first time in Turkey in 2010, Kuveyt Türk, which continues to hold a leading position, executed 48 domestic issuances amounting to 26.06 billion TL by the end of 2024. Furthermore, within the framework of the CP Program established in 2023, the bank has issued two international bonds valued at 600 million TL and \$102.3 million respectively. Over the years, Kuveyt Türk has issued sukuk certificates in various currencies such as Turkish Lira, US Dollar (USD), and Malaysian Ringgit (MYR) both domestically and internationally, totaling 90.79 billion TRY, 2.08 billion USD, and 800 million MYR respectively. Some portions of these issuances are currently in circulation, with 26.66 billion TRY - 49 certificates and 102.3 million USD - 3 certificates.

In 2021, Kuveyt Türk accomplished another milestone by issuing the world's first Sustainable Capital-Like Sukuk with a 5-year tenure and 350 million USD value. This issuance received strong demand from over 150 investors from a wide geographical area including Gulf, Asia, Europe, and America. The demand reaching 12.3 times the issuance amount, is a strong reflection of the Bank's robust credibility both internationally and locally. This issuance set a record in the Turkish market by receiving the highest demand and achieving the lowest pricing since 2017. Due to its Environmental, Social,



and Governance (ESG) structure, the issuance also attracted significant interest from green funds based in Europe and the United Kingdom.

As a result of the successful issuance, our bank was honored with three international awards in 2022:

Kuveyt Türk has established a new benchmark in Türkiye by issuing a 600 million Turkish Lira bond in the international market as part of its CP Program in 2024.

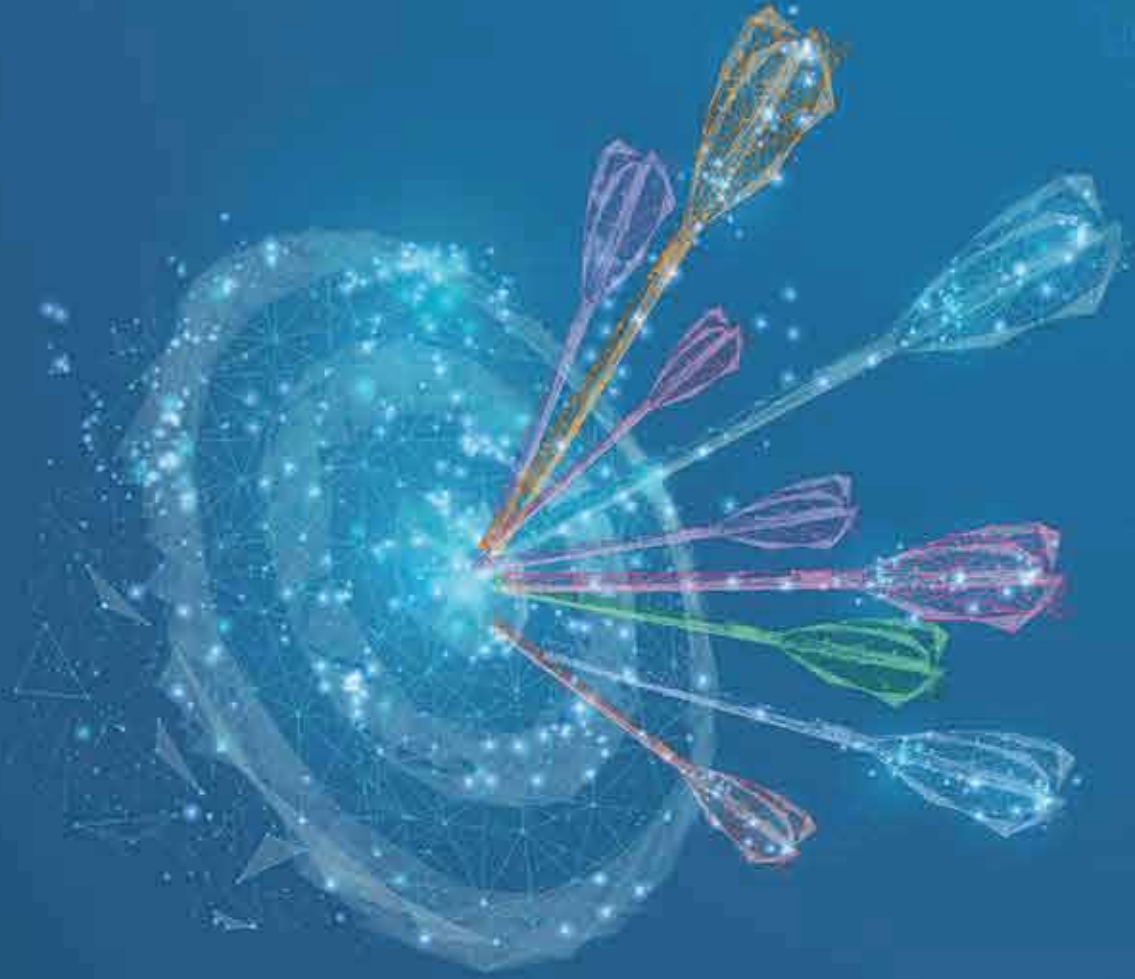

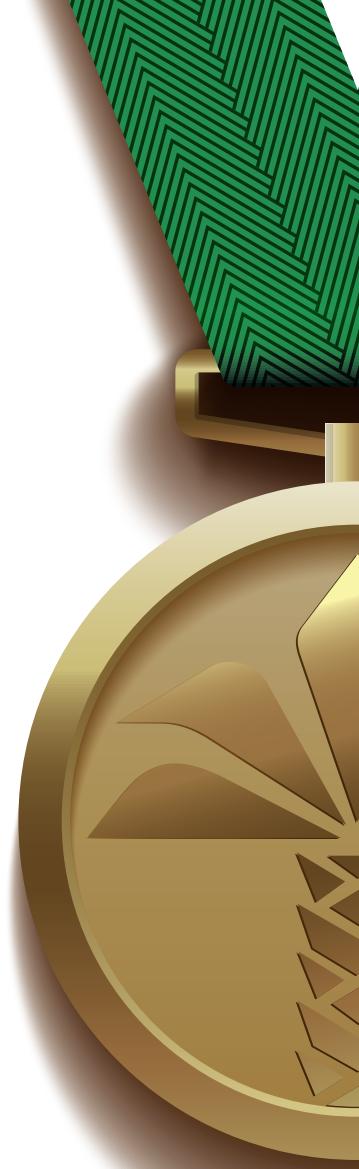

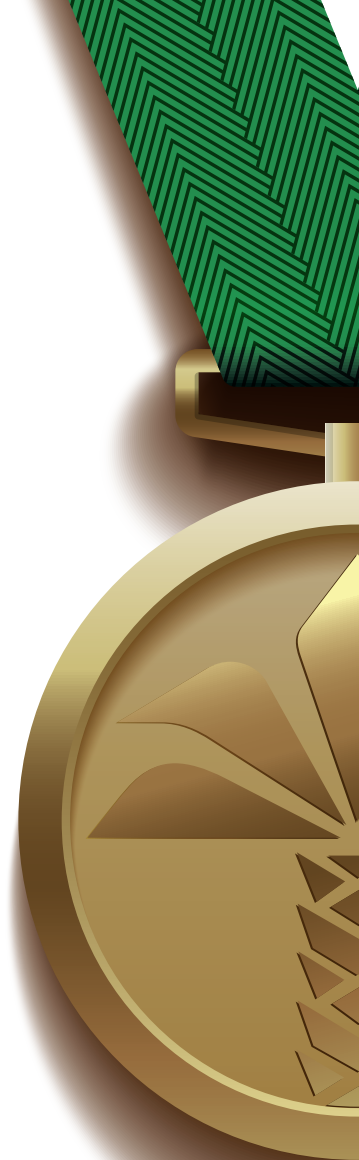

# We Conserve the Cultural Heritage

So far, a large number of restoration projects for protecting and saving historical and cultural heritage of Turkey have been assumed by Kuveyt Türk leaving a number of permanent works such as books and documentaries behind.

Among the restoration works supported by Kuveyt Türk with the responsibility for “protecting the landmark buildings and historical traces in the city” are Grand Ortaköy Mecidiye Mosque, a very unique historical building that forms the unprecedented silhouette of Istanbul, the tomb of Buhurizade Mustafa Efendi located in Istanbul, Azapkapı Saliha Sultan Fountain in Istanbul and Bursa Kozahan Foundation in Bursa.

## We Leave Reference Books into the Future

Kuveyt Türk also supports the efforts to keep the cultural heritage alive by means of books.

These books include two large size prestigious books “Kaybolan Meslekler” (Disappearing Crafts) and “Kaybolan Çesmeler” (Disappearing Fountains).

On the other hand, the book “Evliya Celebi Road to Hajj” (Evliya Çelebi Hac Yolu) has been published as a rich reference book together with a documentary and photography exhibition taking place simultaneously with the same name. The book “Grand Mecidiye Mosque and Ortaköy” has been published in order to keep in memory the traces revealed after the restoration works.

Kuveyt Türk recently added to its Cultural Publications in 2016, the child book “Songs of Birds”.

The life of the composer Hâfız Amir Ateş is depicted in the work titled "Composer Hâfız Amir Ateş," and his significant compositions have been compiled into a two-CD album featuring hymns and songs.

In the work "The Symbol of Ayasofya - Kazasker Mustafa İzzet," the life, ideas, and works of the great calligrapher, musician, ney player, and mystic Kazasker Mustafa İzzet Efendi are presented.

## Kuveyt Türk's Helping Hand to Rakhine

Kuveyt Türk Participation Bank continues holding the hands of needing people as reflected in its mission of becoming a bank with social responsibility. Giving a helping hand to Rohingya Moslems in Rakhine state, Myanmar who are systematically persecuted and forced to flee their mainland, Kuveyt Türk has at the first step donated 1 million to the region. In addition to that support in the form of donation, Kuveyt Türk has also launched a humanitarian aid campaign for Rakhine among its employees and clients in order to satisfy the needs of Rakhine Moslems considering its donation efforts as a starting step. We aim that the aids reached to the region through Turkish Crescent would regrow the hope of Roginyha Moslems.

## Aid Campaign for Pakistan Flood Victims

Donation campaign has been launched in favor of flood-hit people in Pakistan in 2010. Around 100 families hit by heavy floods have been sheltered at "Kuveyt Türk Brotherhood Village" established with donations and in cooperation with Turkish Crescent. Immediate needs of the victims have been satisfied for a year. Foods, clothing, stationery and similar consumables have been supplied to the people in need by Kuveyt Türk.

## International Research Center for Islamic Economics and Finance

## Van Earthquake Donation Campaign

## Ortaköy Great Mecidiye Mosque Restoration

Making an important contribution to the identity of Istanbul, Grand Mecidiye Mosque dating back to mid-19th century, i.e. toward the end of Ottoman Era was re-opened to praying in 2014 after a 3-year restoration with the support of Kuveyt Türk. The mosque has been renovated maintaining its historical pattern through painstaking and careful restoration works. As part of the restoration works, not only the existing structure has been restored but also

Following the completion of the restoration, the book “Grand Mecidiye Mosque and Ortaköy” edited by Mehmet Baha Tanman was published in 2014. The book reveals the historical and cultural features of a civilization with information about the Bosphorus and surrounding buildings. It has become a remarkable reference book about the Ottoman era architectural works. Also focusing on the architectural details of Grand Mecidiye Mosque, the book serves as an archive for the findings and documents revealed during the restorations works.

## National Solidarity Campaign

Kuveyt Türk contributed 20 million TRY to the National Solidarity Campaign, which was initiated to support those in real need affected by the coronavirus pandemic in 2020.

## Elazığ Earthquake Donation Campaign

## KAÇUV “Support for Hope” Project

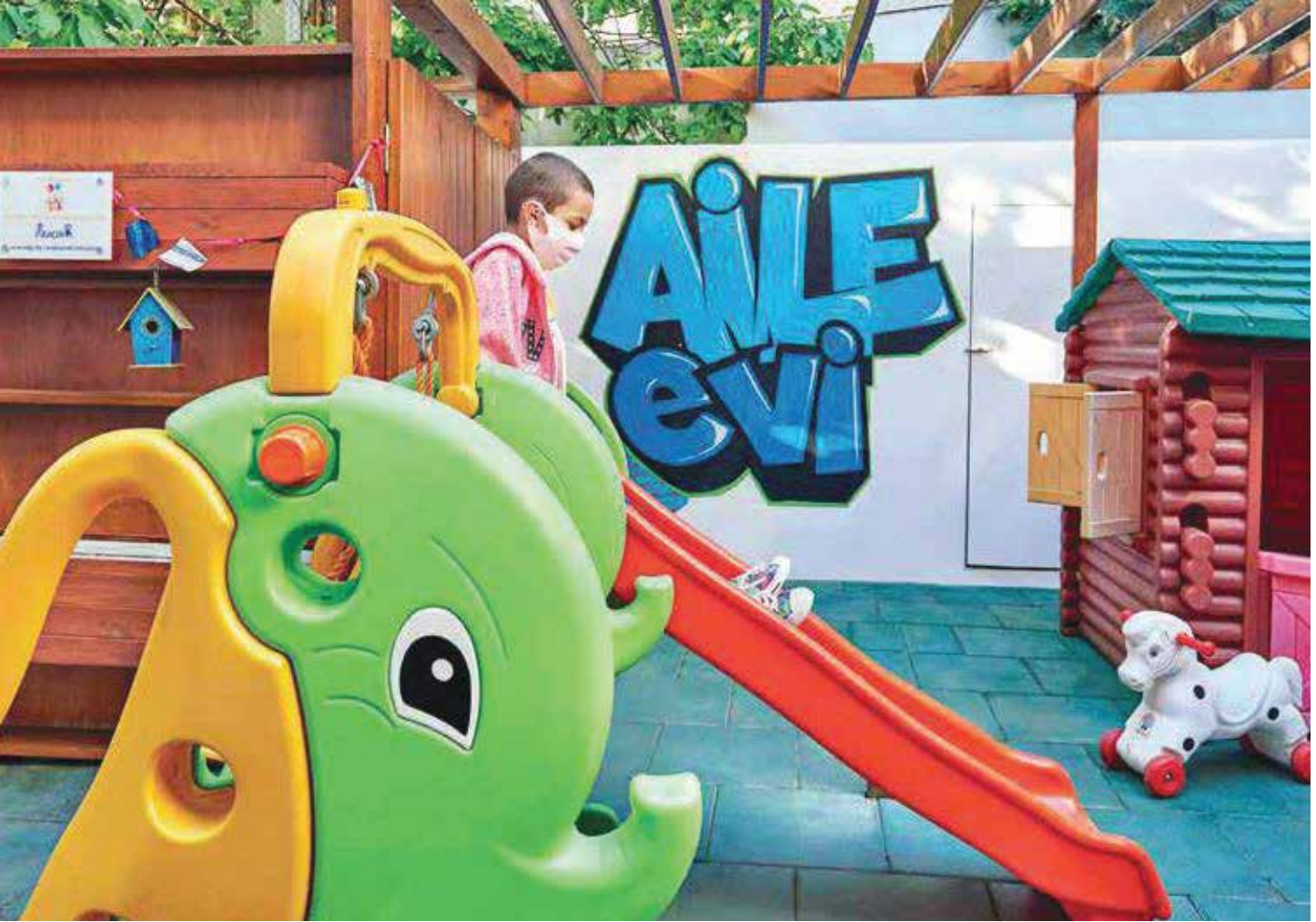

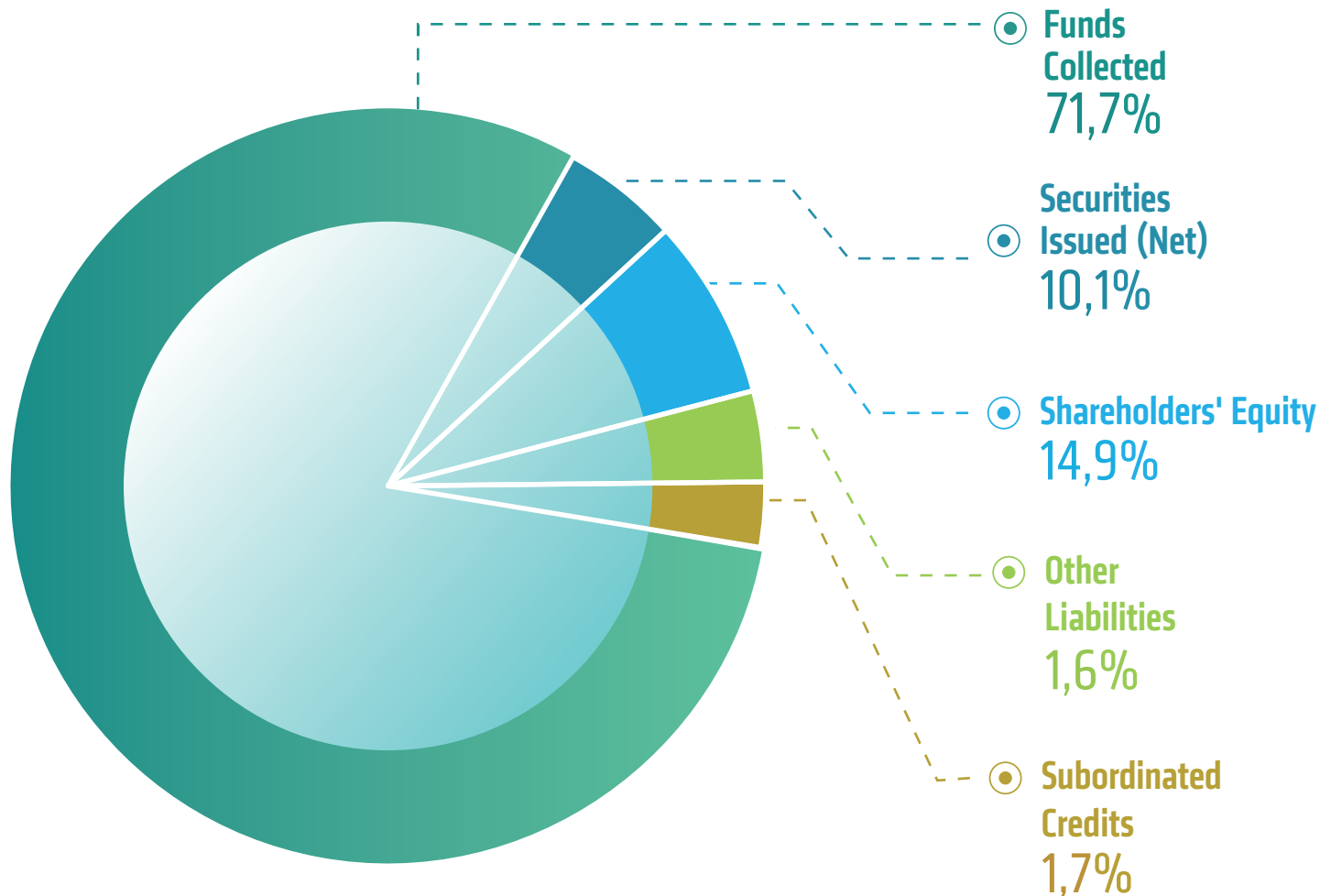

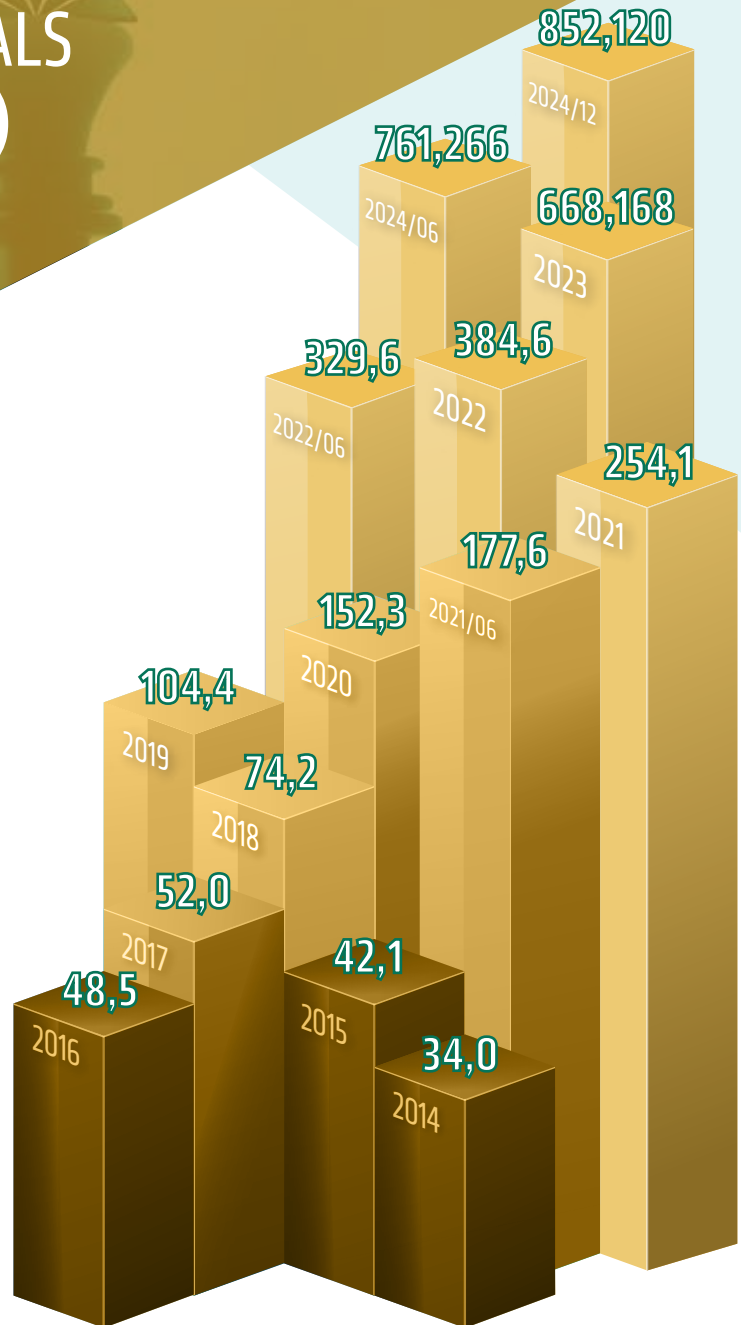

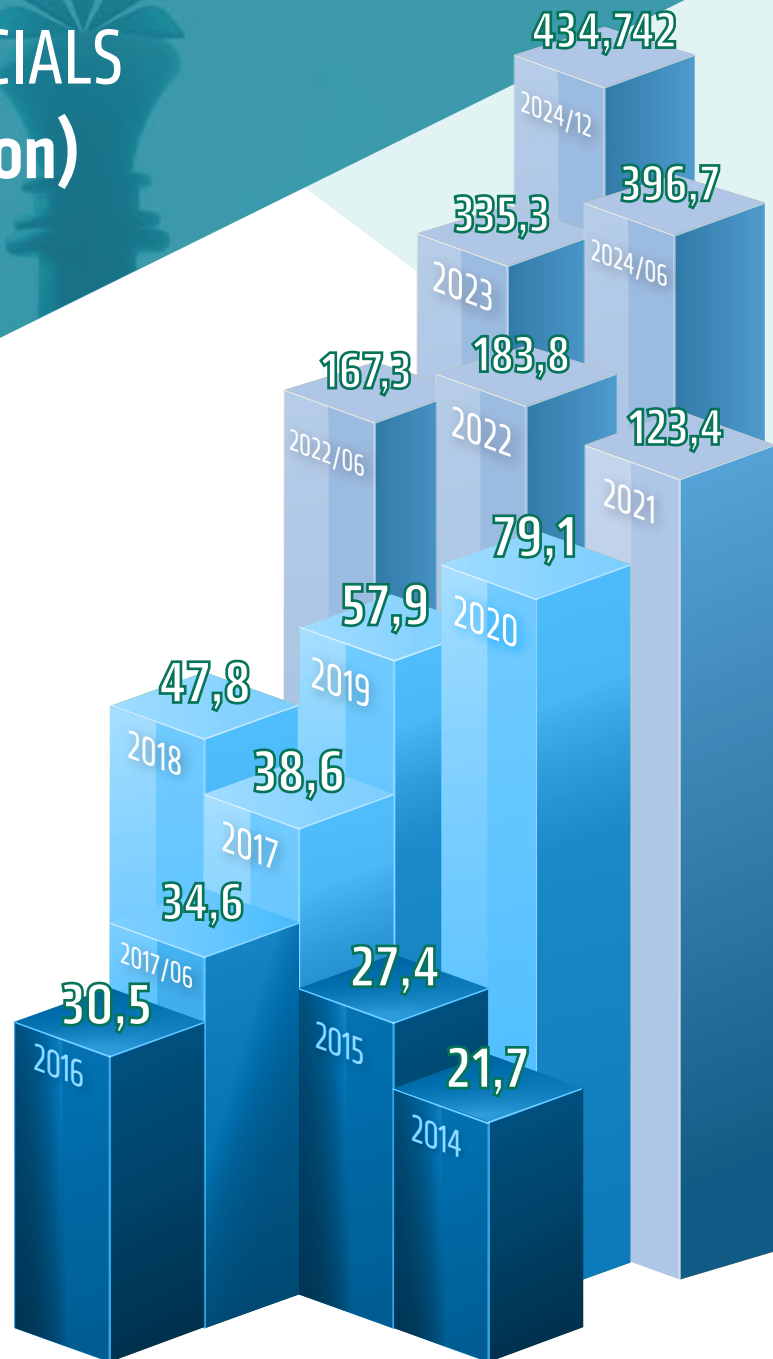
